## **T2. PROJECT DESCRIPTION**

The purpose of this RFQ is to engage service providers that can effectively deliver training for the QCTO programme **Occupational Skills New Venture Creations ID SP-210401** for a duration of 30 days to the identified target group. The programme targets have been recruited in collaboration with NPOs (successful bidders will be provided with the details of the NPO upon appointment), and contracts have been established with these NPOs. The successful bidder, in partnership with the NPOs, will be responsible for screening potential learners to ensure they meet the criteria for participation in the training programme. This collaborative effort aims to enhance the skills and employability of the selected participants, contributing to the broader goals of workforce development and empowerment. The Training Service provider will be responsible for training of 30 learners that are to be recruited from the local communities within a radius of 10KM from Soweto where IDT implements a project in the City of Johannesburg.

The IDT Skills and Training programme aims to empower the selected members of the communities where IDT implements projects targeting mainly women, youth and people with disabilities to obtain accredited qualifications to prepare them for formal employment or to start their businesses.

The targeted skills programme that the Training Service Provider must submit the RFQ for is the **Occupational Skills Programme: New Venture Creations**

## **T2.1. SKILLS RATIONALE**

There is a need for skills programmes within the New Venture Creations and these skills programmes are being carefully monitored and located in the broader skills and competency framework for New Venture Creations. The aim is to ensure that all initiatives for developing skills are integrated into the broader skills and competency framework for New Venture Creations. This approach will support the effective training and competence of learners, ensuring their skills meet the industry standards. The learners will acquire relevant skills to be competent in the sector or other initiatives are directly related to the registered New Venture Creations qualification and adhere to the relevant sector designations. This means that any skills programmes or any other initiative for developing skills within the New Venture Creations sector need to be related to the registered New Venture Creations qualification as well as the registered designations within the sector.

## **T2.2 THE OBJECTIVES OF THE IDT TRAINING AND SKILLS DEVELOPMENT**

**The objectives of the IDT development programme are:**

1. To empower communities to exit the EPWP programme with relevant skills that will assist them to access economic opportunities.
2. To train and build the capacity of unemployed people and work seekers to prepare them in making transitions into employment or self-employment.
3. To provide an opportunity for unemployed youth and old people who do not have matric or meet the requirements to enrol in post-matric education but have skills suitable for Recognition of Prior Learning (RPL).

## **T2.3 SCOPE OF WORK SHALL INCLUDE:**

1. Screening of learners to get to **thirty five (35) qualifying learners** for **Occupational Skills Programme: New Venture Creations over a period of 15 days** from the targeted communities.
  - a. Entry requirements
  - b. One learner must be a person with disability
2. Facilitate the implementation of the training for the 35 learners by the accredited trainers and manage all the training-related administrative activities
3. Keep records of the attendance of learners and facilitate the payment of stipends, UIF and COIDA in line with the applicable regulations.
4. Work closely with the IDT Programme Management team and NPO to manage the placement of learners in the IDT programmes for experiential learning.
5. Provide monthly reports on progress and financial expenditure in line with the templates to be provide.
6. Address all issues that may emerge on training and project.

The tenderer shall within two weeks after receiving a completed copy of this agreement, including the schedule of deviations (if any), contact the Employer or the employer's agent (whose details are given in the contract data) to arrange the delivery of any bonds, guarantees, proof of insurance and any other documentation to be provided in terms of the conditions of contract identified in the contract data. Failure to fulfill any of these obligations in accordance with those terms shall constitute a repudiation of this agreement.

Notwithstanding anything contained herein, this agreement comes into effect on the date when the tenderer receives one fully completed original copy of this document, including the schedule of deviations (if any). Unless the tenderer (now contractor) within five working days of the date of such receipt notifies the employer in writing of any reason why he cannot accept the contents of this agreement, this agreement shall constitute a binding contract between the parties.
